### 叁、申請注意事項/Application Instructions

#### 一、申請資格 Eligibility of Applicants:

申請資格係依據教育部（外國學生來臺就學辦法）所規定。辦法如經修正，將以教育部公告為準。有關辦法之最新訊息，請查閱教育部網站 <http://www.edu.tw>。

The application qualifications are based on “MOE Regulations Regarding International Students Undertaking Studies in Taiwan.” If the MOE (Ministry of Education) regulations were updated or changed, the MOE regulations announced by MOE prevail. For the latest information regarding the MOE regulations, please refer to the website: <http://www.edu.tw>.

1. 具外國國籍且未曾具有中華民國國籍，符合下列規定者：

An individual of foreign nationality, who has never held nationality status from the Republic of China and who meets the following requirements:

(1) 未曾以僑生身分在臺就學。

An individual who has never undertaken studies in Taiwan as an overseas Chinese student.

(2) 未於申請入學當學年度接受海外聯合招生委員會分發。

An individual who has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students.

2. 具外國國籍且符合下列規定，於申請時並已連續居留海外六年以上者：

An individual of foreign nationality status, pursuant to the following regulations and who has stayed overseas continuously for no less than 6 years.

(1) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

An individual who has a nationality status from the Republic of China at the time of their birth but does not hold a household registration must state this on their college application.

(2) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

An individual who has had nationality status from the Republic of China but has no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years after an annulment of their R.O.C. nationality by the Ministry of the Interior.

(3) 前二款均未曾以僑生身份在臺就學，且未於當學年度接受海外聯合招生委員會分發。

Regarding individuals mentioned in both of the above subparagraphs they must not have studied in Taiwan under the status of an overseas Chinese nor received placement permission for an academic school year by the University Entrance Committee for Overseas Chinese Students.

3. 依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准，得不受前二項規定之限制。

According to the Education Cooperation Framework Agreement, a foreign national who was selected by a foreign government, organization, or school, and does not hold a household registration from the time of their birth is not subject to the limitation as prescribed in the

preceding two paragraphs after receiving the approval from the designated authorized government educational institutions.

4. 具外國國籍、兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者。

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or another foreign country for no less than 6 years is qualified to apply for admission under these regulations.

5. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者。

An applicant being a former citizen of Mainland China and holds a foreign nationality, having no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years is qualified to apply for admission under these regulations.

\* 備註 1：中華民國國籍法第二條：

Note1 : Article 2 of the Nationality Act:

有下列各款情形之一者，屬中華民國國籍：

A person who meets one of the following requirements has acquired nationality of Republic of China:

一、出生時父或母為中華民國國民。

A person whose father or mother was, at the time of his (her) birth, a citizen of the Republic of China.

二、出生於父或母死亡後，其父或母死亡時為中華民國國民。

A person born after the death of his (her) father or mother who was, at the time of his (her) death, a citizen of the Republic of China.

三、出生於中華民國領域內。父母均無可考，或均無國籍者。

A person born in the territory of the Republic of China and whose parents are both unknown or are stateless.

四、歸化者。

A naturalized person.

前項第一款及第二款之規定，於本法修正公佈時之未成年人，亦適用之。

The provisions specified in subparagraphs 1 and 2 of the preceding Paragraph shall apply to minor children on the date of the promulgation of the amendment of this law.

\* 備註 2：所稱海外，指大陸地區、香港及澳門以外之國家或地區；

所稱連續居留，指外國學生每曆年在國內停留期間未逾一百二十日。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

Note2: "Overseas" is limited to countries or regions other than Mainland China, Hong Kong and Macao; the term "continuously" means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. The only exceptions to this method of calculation are for those who fulfill one of the following requirements with written supportive proof:

甲、 就讀僑務主管機關舉辦之海外青年技術訓練班或本教育部認定之技術訓練專班。

Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by the Ministry of Education;

乙、 就讀教育部核准得招生外國學生之各大專校院華語文中心，合計未滿二年。

Attended a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by the Ministry of Education, and to which the total length of stay is less than 2 years;

丙、 交換學生，其交換期間合計未滿二年。

Exchange students, whose length of total exchange is less than 2 years;

丁、 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

6. 符合教育部採認之高中、大學或獨立學院畢業者（請參考教育部國際文教處網站：<https://www.edu.tw/>）。

申請學士班者須具國外高中畢業學歷、申請碩士班者須具大學畢業學歷、申請博士班者須具碩士畢業學歷，或具有與我國學制相當之同等學力資格者。

Applicants who have graduated from high school, college or university recognized by the Ministry of Education, ROC can apply for admission (Please refer to the website of the Bureau of International, Cultural, and Educational Relations, Ministry of Education at <http://www.edu.tw/>).

International students with a high school diploma are eligible to apply for undergraduate programs; bachelor's degree holders for Master's programs; Master's degree holders for doctoral programs.

\* 申請人畢業學校須為我國教育部認可或當地國政府權責機關或專業評鑑團體認可，符合教育部「[大學辦理外國學歷採認辦法](#)」規定之學校或我國政府立案之學校，否則恕不受理申請。

Those institutions from which applicants graduated must be accredited schools approved by the Ministry of Education of the R.O.C. as well as in accordance with the rules of [Foreign Degrees Authentication promulgated by Ministry of Education](#). Otherwise, the application will not be accepted.

7. 本校教學以中文為主，申請人應具備中文聽、說、讀、寫能力。

**Instruction in this university is mainly given in Mandarin Chinese; applicants should have sufficient listening, speaking, reading and writing ability in Chinese Language.**

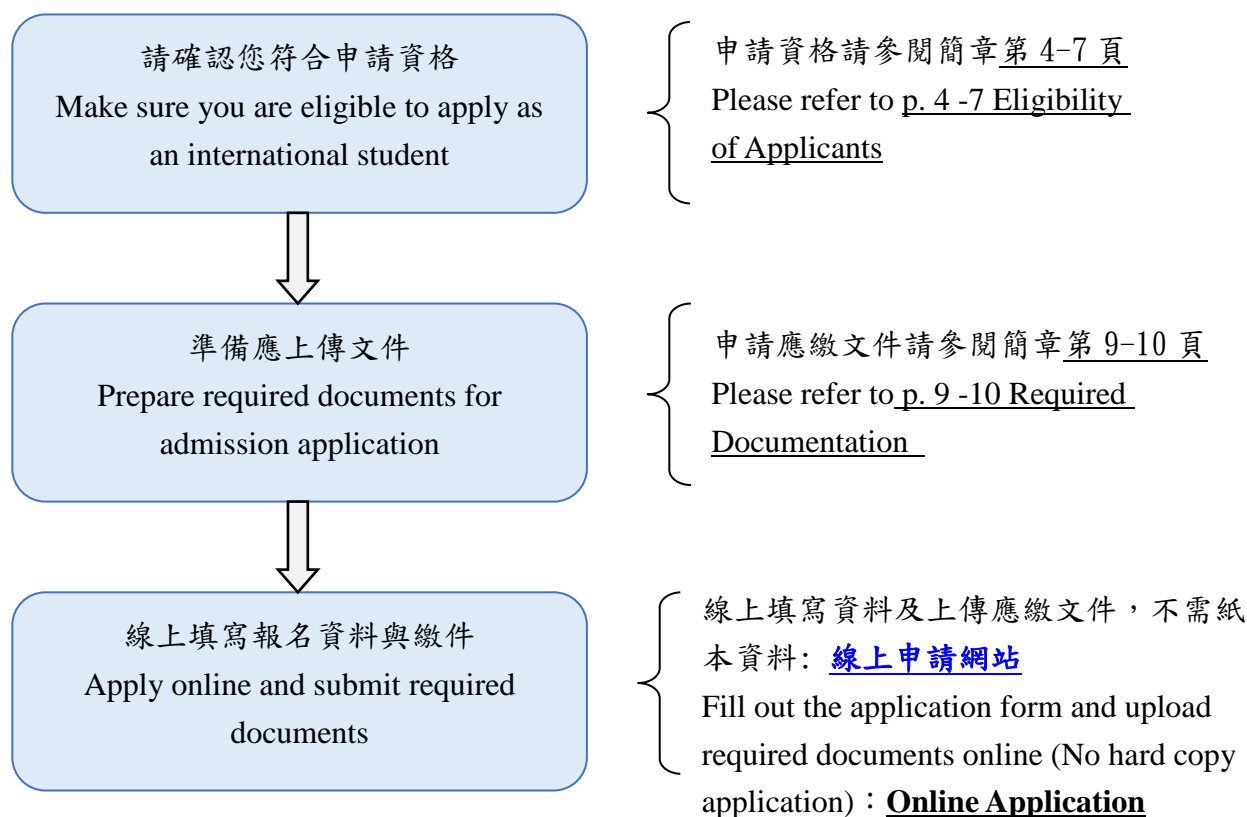

#### 四、申請應繳交文件 Required Documentation

1. 入學申請表（請貼妥二吋半身照片一張）。(如附錄 1)

Application form with one recent 2-inch passport photo. (see appendix 1)

2. 經我國駐外使領館、代表處、辦事處或其他經外交部授權機構（以下簡稱駐外館處）驗證，之外國學校最高學歷或同等學力證明文件及成績單（中、英文以外之語文，應附中文或英文譯本）。

Your highest-level certificate or equivalent academic attainment and transcript of academic records issued by an international education institution (A copy of the translation in Chinese or English is necessary, if the original diploma is in a language other than Chinese or English), which must be authenticated by a R.O.C. embassy, consulate, representative office or other agencies authorized by Ministry of Foreign Affairs (MOFA), Taiwan, (hereinafter referred to as “a Taiwan’s overseas representative office”).

- (1) 應屆畢業生申請者，申請時可先檢送當學期在學證明，但至遲須於 111 年 6 月 30 日前取得畢業證書並經我國駐外館處驗證，否則取消錄取資格。（中、英文以外之語文，應附經驗證之中文或英文譯本）

Graduating students must submit the certificate of enrollment if they have not received their diploma during the application process. However, if admitted, notarized diploma must be submitted before June 30, 2022, or student’s admission offer will be revoked (If the original documents are not in English or Chinese, an English or Chinese translation notarized by a Taiwan overseas representative office is also required.)

- (2) 外國學生已在臺完成學士以上學位，繼續申請入學碩士以上學程者，得檢具我國各校院畢業證書及歷年成績證明文件，依規定申請入學。

An international student who has completed a bachelor’s degree or a higher degree in Taiwan and is applying to be admitted to do a master’s degree program or a higher degree may submit their graduation certificate from a university or tertiary college in Taiwan and transcripts for each year of their studies .

- (3) 大陸地區學歷：應依《[大陸地區學歷採認辦法](#)》規定辦理。

Academic credentials earned in mainland China should be handled in accordance with [Regulations Governing the Recognition of Educational Qualifications from Mainland China](#).

■ 持大陸地區學士學位以上(含)者，另須繳交「學位證（明）書」。

Applicants with a bachelor’s degree or above from one of the institutions in Mainland China, are also required to submit a certificate of degree conferral.

- (4) 香港或澳門學歷：應依《[香港澳門學歷檢覈及採認辦法](#)》規定辦理。

Academic credentials earned in Hong Kong or Macao should be handled in accordance with [Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao](#).

- (5) 其他地區學歷：

Academic credentials earned in other areas:

■ 海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。

Academic credentials earned at overseas Taiwan schools or Taiwan schools in mainland China will be regarded as equivalent to credentials earned at domestic schools.

- 大陸地區、香港或澳門以外之國外地區學歷，應依《[大學辦理國外學歷採認辦法](#)》規定辦理。但設校或分校於大陸地區之外國學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。

Other areas academic credentials not mentioned above will be handled in accordance with [Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education](#). However, academic credentials earned from a foreign academic institute or university branch established in mainland China must be notarized in mainland China, then examined and verified by an agency established or appointed by the Executive Yuan, or through a private agency commissioned by the Executive Yuan.

Verification of nationality (e.g. a photocopy of your passport).

4. 財力證明(請選擇以下任何一種方式繳交)

A Financial statement (Please select one of the following):

- (1) 由金融機構提出足夠在臺就學之最近三個月內財力證明 (美金 4,000 元 或新臺幣 100,000 元以上之財力證明)。

Validated financial statements within the past 3 months by financial institutions. Indicating that sufficient funds are available to support that applicant during his / her stay in Taiwan. (Document of financial support with a minimum balance of US\$4,000 or NTD 100,000)

- (2) 存款證明非申請人帳戶，需附上資助者之最近三個月內存款證明及財力保證書。(見附錄 3)

If the financial statement is not in the name of the applicant, please provide a bank statement within the past 3 months with sufficient funding, along with the form “Financial Guarantee” (see appendix 3)

- (3) 獎學金學生須檢附全額獎學金得獎證明。

Students with full scholarship must provide proof.

\* 若存款證明之幣值非新臺幣或美金，申請者需於存款證明上註明匯率，並換算成相當於新臺幣或美金之總額。

If the currency of the bank statement is in neither NT dollars nor US dollars, applicants shall convert the total amount and indicate the exchange rate on the bank statement.

2 recommendation letters. The recommendation letters must be written by 2 teachers or senior officials. (written in Chinese or English, please select one of the following) .

\* 視個案情況，本校得要求申請者檢附其他證明文件以審核其申請資格與學歷，例如：入出國日期證明書、未設戶籍切結書、父母親中華民國身分證件、喪失國籍許可證書等等。

Depending on the circumstances, the University may request additional documents to review your eligibility and educational background, such as the Certificate of Entry and Exit Dates, Non-Household Registration Declaration Form, a document that proves your father or mother has/had R.O.C. nationality status, the Certificate of Nationality Annulment, and so on.

四、逾期末回覆入學錄取報到單者，視為放棄錄取資格。

Late reply of the Statement of Registration Intention will regard as abandonment of the registration.

## 伍、簽證 Visa Issues

一、入學許可並不保證簽證取得，簽證需由我國駐外館處核給。部分駐外館處受理簽證申請時要求繳交華語文能力證明(擬就讀中文授課之系所學程)或英語能力證明(擬就讀英文授課之系所學程)。相關簽證申請規定，請逕向臺灣駐外館處查詢。

The acceptance letter or admission notice does not guarantee visa issuance. Visas are approved by the Ministry of Foreign Affairs/ Taiwan Overseas Representative Offices. Some Taiwan Overseas Representative Offices may require the applicants to submit proof of Chinese Language Proficiency (enrolling in Chinese-taught programs) or proof of English Language Proficiency (enrolling in English-taught programs) for their visa application. For the requirements of a visa application, please contact the Taiwan Overseas Representative Office in/near your country.

\* 申請人於申請入學時，若已持停留/居留簽證在臺合法停留(例:就讀大專校院、華語班、實習、工作等)，倘前一階段在臺事由結束，欲在臺繼續升學，其簽證得否在臺申換，核定與否由外交部領事事務局決定。若未予核准，則須離境向駐外館處重新申請來臺就學居留簽證。

Those who have already held a Visitor Visa/Resident Visa at the time of application, (i.e. studying at Universities and tertiary colleges、studying at Chinese Language Center、Internship or Employment). If they would like to change the status of visa to pursue study at TTU without leaving the country. The approval or denial of visa applications are subject to The Ministry of Foreign Affairs and the office reserves the right to deny visa application under certain circumstances. If been denied, applicants must exit the country to apply for a student resident visa at a Taiwan's consulate.

二、來臺入學辦理簽證時，需繳交健康證明書（包括人類免疫缺乏病毒檢驗報告）至外交部領事事務局。

Applicants must submit an original copy of a medical examination report (including an HIV Antibody Test) to a nearby R.O.C. embassy, consulate office, or Taipei Economic & Culture Office when applying for visa.

\* 根據「人類免疫缺乏病毒傳染防治及感染者權益保障條例」第 18 條規定：中央主管機關對入國（境）停留達三個月以上或居留之外國人、大陸地區人民、香港或澳門居民，得採行檢查措施，或要求其提出最近三個月內人類免疫缺乏病毒抗體之檢驗報告。前項檢查或檢驗結果呈陽性反應者，中央主管機關應通知外交部或入出國管理機關撤銷或廢止其簽證

或停留、居留許可，並令其出國（境）。外國人、大陸地區人民、香港或澳門居民拒絕依第一項規定檢查或提出檢驗報告者，中央主管機關應通知外交部或入出國管理機關撤銷或廢止其簽證或停留、居留許可，並令其出國（境）。

According to Article 18 of the “HIV Infection Control and Patient Rights Protection Act,” the central competent authority may impose examination measures upon aliens, citizens of the mainland China, residents of Hong Kong or Macau who have entered the country (border) and stayed for more than three months, or require them to submit test reports for HIV antibodies taken within the last three months.

If the test results are positive, the central competent authority shall notify the Ministry of Foreign Affairs or the Immigration Office to revoke or annul their visas or permits of stay or residence, and order them to leave the country (border).

For aliens, citizen of the mainland China, residents of Hong Kong or Macau who refuse to undergo medical examinations or submit test reports as per regulations of Paragraph 1, the central competent authority shall notify the Ministry of Foreign Affairs or the Immigration Office of such cases to revoke or annul their visas or permits of stay or residence, and order them to leave the country (border).

- \* 依行政院衛生署疾病管制局規定，自 2009 年 1 月起，凡申請來臺居留簽證，須檢具麻疹及德國麻疹抗體陽性報告或預防接種證明。請參閱外交部領事事務局網站 (<http://www.boca.gov.tw>)。

According to regulations of the Centers for Disease Control (CDC), Dep. of Health, Executive Yuan, R.O.C., since January 2009 those who apply for a resident visa to stay in Taiwan have to submit a medical report showing immunity to measles and rubella or proof of vaccination against measles and rubella. Please refer to the BOCA website (Bureau of Consular Affairs, Ministry of Foreign Affairs, R.O.C. <http://www.boca.gov.tw> for details.

## 陸、報到及註冊 Report and Registration

- 一、已完成「報到」之新生應依錄取通知之規定至教務處註冊組辦理報到及註冊手續，並繳交 1. 畢業證書正本及成績單正本 2. 經我國駐外館處驗證之畢業證書影本及成績單影本，驗畢後歸還，始得註冊入學。

Admitted students who have filled out “The statement of Intent Register” must arrive at the university prior to the date specified for orientation for freshmen. At the time, be prepared to show register division of Academic Affairs Office your 1. Original Highest-Level Diploma and Transcript 2. A copy of original Highest-Level Diploma and transcripts officially stamped/sealed by a Taiwan overseas representative office. (Original documents will be returned after inspection.)

- \* 如經查驗不符，或逾期未報到，取消入學資格。

Any forged document or delay in registration will result in the denial of admission.

二、經核准入學之外國學生，以當年入學為原則，不另保留入學資格。

Students who have been granted admission must matriculate only for the academic year for which they are accepted.

三、學生於註冊時，應檢附於已於國外投保自入境當日起至少四個月效期之經駐外館處驗證之醫療及傷害保險。

At the time of Registration, admitted students should present their proof of insurance which includes both medical and personal accident coverage for a period of at least four months from the date of their arrival in Taiwan. The overseas insurance proof should be verified by the Taiwan Overseas Office.

If any document submitted is found to be false, the admission will be cancelled. If the forged document is found after admission or graduation, the student status will be revoked, the degree diploma will be retracted. All the above-mentioned violations will be reported to the Ministry of Education, and criminal liability will be imposed.

According to the regulation of the MOE (Ministry of Education), those who have been approved for Initial Household Registration, Moving-in Registration, Acquisition or Restoration of Nationality during their study in Taiwan and have thus ceased to process the status as foreign students, shall be expelled from any attending school. However, an international student admission procedure has been handled in the same manner as domestic students, or who meet the conditions in accordance with Subparagraph 1 to Subparagraph 3 of Paragraph 1 of Article 4 of Nationality Act, are not subject to this restriction. Moreover, those who withdraw or are expelled from any attending school in the Republic of China due to misbehavior, academic failure or conviction of penal crime may not thereafter apply again for admission under “Regulations Regarding International Students Undertaking Studies in Taiwan”. Violation of this regulation, once verified, will result in the denial of admission.
