The Regulation of Tatung University Scholarships and Financial Aid for

International Students

Approved at the Administrative Meeting on 9th September 2021 Approved at the Administrative Meeting on 9th November 2023

- Article 1 Tatung University established The Regulation of Tatung University Scholarships and Financial Aid for International Students to encourage outstanding international students to study at the University (hereinafter referred to as "this regulation").
- Article 2 The term "international students" in this regulation is in accordance with the given definition of Article 2 and Article 3 in "Regulations Regarding International Students Undertaking Studies in Taiwan". This regulation applies to international students who have applied for and gained admission to Tatung University only.

 International students on a Dual Degree Program or an Exchange Program are not eligible.

International students on a Dual Degree Program or an Exchange Program are not eligible to apply for these scholarships as they are not included in the given definition of "international students" in this regulation.

Article 3 The awarding terms and conditions of these scholarships are addressed as follows:

1. Scholarship for international undergraduate students:

- (1) First-year international undergraduate students who have completed the registration procedure are eligible to grant 50% of their tuition fees (or equivalent) of both the first and second undertaking semesters as a scholarship.
- (2) Second-year to Fourth-year international undergraduate students who have completed the registration procedure are eligible to grant 30% of their tuition fees (or equivalent) of both the first and second undertaking semesters as a scholarship. For granting this scholarship, the students must meet the following conditions in the preceding semester:
 - (i)having an average score of 65 or above;
 - (ii)having at least 50% of credits grade with a pass; and
 - (iii)having a conduct grade of 80 or above.

These conditions do not apply to the students who upgrade to a higher class level to be second-year to <u>fourth-year</u> students, in which case, they shall grant 30% of their tuition fees (or equivalent) of both the first and second undertaking semesters as a scholarship after completing the registration procedure.

- (3) Students who have no academic records from the preceding semester due to suspension and those who are delayed in graduating are not eligible for the scholarship. However, students recommended by the university for overseas partner school exchange programs or dual-degree programs, without prior semester grades, are entitled to the corresponding grade-level scholarship upon successful completion of the registration process, exempt from the aforementioned conditions.
- (4) Award candidates must complete the enrollment procedure and pay the enrollment fees or they will be exempted from the candidate list. Further, students must have no record of requesting a suspension or withdrawal of the study or leaving the university

for any purpose during the undertaking semester.

(5) The award amount includes the "Tatung University Alumni Donation Scholarship".

2. Scholarship for international master's students

The applications submitted by <u>enrolled students</u> will be reviewed in a meeting convened by the Dean of <u>International and Cross-Strait Affairs</u>. Students will be awarded either an 'Outstanding Scholarship Type A', 'Outstanding Scholarship Type B' or the 'Enrollment Scholarship', with only one of the three scholarships being granted per student. The number of award candidates may vary each academic year according to the university budget.

(1) Outstanding Scholarship Type A, Outstanding Scholarship Type B

A. Eligibility:

- (A) New Students: Applicants who apply for admission through the university's international student application process.
- (B) Current Master's Students: Second-year students must have achieved a total average academic score of 80 or above in the preceding academic year, with no major violations, to be eligible for reapplication.

B. Award Details:

(A) Outstanding Scholarship Type A:

Full exemption of tuition and on-campus accommodation fees.

Exclusions: Personal insurance fees (such as health or medical insurance, student group insurance), summer and winter vacation accommodation, computer and internet communication usage fees.

(B) Outstanding Scholarship Type B:

Full exemption of tuition fees.

Exclusions: On-campus accommodation fees, personal insurance fees (such as health or medical insurance, student group insurance), computer and internet communication usage fees.

C. Renewal Criteria for the Second Semester of the Award Year:

Have an average score of 80 or above with a conduct grade no less than 80 in the preceding semester.

- D. First-year master's students must take at least 6 credits each semester.
- E. Award candidates must complete the registration procedure of the current academic year or they will be exempted from the candidate list. Please remember that the scholarship offer cannot be deferred.
- F. International master's students who are on an extension of study are not eligible to apply for this scholarship.
- G. Simultaneous receipt of the "Tatung University Alumni Donation Scholarship" is not allowed.

(2) Enrollment Grant:

A. Eligibility:

(A) New Students: Applicants who apply for admission through the university's international student application process.

(B) Current Master's Students: Second-year students must have achieved a total average academic score of 75 or above with a conduct grade no less than 80 in each semester of the last academic year.

B. Award Details:

NT\$25,000 per semester, inclusive of the "Tatung University Alumni Donation Scholarship".

- C. Renewal Criteria for the Second Semester of the Award Year:Have an average score of 75 or above with a conduct grade no less than 80 in the
- preceding semester.

 D. First-year master's students must take at least 6 credits each semester.
- E. Award candidates must complete the enrollment procedure and pay the enrollment fees or they will be exempted from the candidate list. Further, students must have no record of requesting a suspension or withdrawal of the study or leaving the university for any purpose during the undertaking semester.
- F. International master's students who are on an extension of study are not eligible to apply for this scholarship.

3. Scholarship for international PhD students

The applications submitted by <u>enrolled students</u> will be reviewed in a meeting convened by the Dean of <u>International and Cross-Strait Affairs</u>. Students will be awarded either an 'Elite Scholarship Type A', 'Elite Scholarship Type B' or the 'Enrollment Grant' for PhD Students. The number of award candidates may vary each academic year according to the university budget.

(1) 'Elite Scholarship Type A', 'Elite Scholarship Type B' for PhD students

A. Eligibility:

- (A) New Students: Applicants who apply for admission through the university's international student application process.
- (B) Current PhD Students: Second-year students must have achieved an average score of 80 or higher in each semester of the last academic year, with a conduct grade of 80 or above. They must also publish at least one academic paper in an international conference or international journal, and be affiliated with Tatung University.

B. Award Details:

(A) Elite Scholarship Type A

Full exemption of tuition and on-campus accommodation fees.

Each semester, a scholarship of NT\$50,000 is provided by the advisor (to be disbursed monthly).

Exclusions: Personal insurance fees (such as health or medical insurance, student group insurance), summer and winter vacation accommodation, computer and internet communication usage fees.

(B) Elite Scholarship Type B

Full exemption of tuition fees.

Exclusions: On-campus accommodation fees, personal insurance fees (such

as health or medical insurance, student group insurance), computer and internet communication usage fees.

- C. Renewal Criteria for the Second Semester of the Award Year:
 Have an average score of 80 or above with a conduct grade no less than 80 in the preceding semester.
- D. First-year PhD students must take at least 6 credits each semester.
- E. Award candidates must complete the registration procedure of the current academic year or they will be exempted from the candidate list. Please remember that the scholarship offer cannot be deferred.
- F. International PhD students who are on an extension of study are not eligible to apply for this scholarship.
- G. Simultaneous receipt of the "Tatung University Alumni Donation Scholarship" is not allowed.

(2) Enrollment Grant:

A. Eligibility:

- (A) Only first- and second-year doctoral students currently enrolled at our university are eligible to apply.
- (B) Second-year students must have achieved a total average academic score of 75 or above with a conduct grade no less than 80 in each semester of the last academic year.

B. Award Details:

NT\$30,000 per semester, inclusive of the "Tatung University Alumni Donation Scholarship."

- C. Renewal Criteria for the Second Semester of the Award Year:
 Have an average score of 75 or above with a conduct grade no less than 80 in the preceding semester.
- D. First-year PhD students must take at least 6 credits each semester.
- E. Award candidates must complete the enrollment procedure and pay the enrollment fees or they will be exempted from the candidate list. Further, students must have no record of requesting a suspension or withdrawal of the study or leaving the university for any purpose during the undertaking semester.
- Article 4 International students who have currently received a scholarship or financial aid issued by the Taiwanese government are not qualified for applying for these scholarships.
- Article 5 Tatung University reserves the right to cancel the scholarships. Scholarships will be canceled if a student misrepresented his/her academic record during the scholarship selection process, in which case, the student must fully return the scholarship that they have already received.
- Article 6 The budget for the scholarships described in these guidelines shall be sourced from the "Tatung University Alumni Donation Scholarship," alumni contributions, or other allocations in the university budget.
- Article 7 Scholarship recipients are required to assist the university in matters related to international affairs programs or events.

- Article 8 Matters not addressed herein shall be handled in accordance with the government and the relevant Tatung University regulations.
- Article 9 This Regulation shall be approved prior to implementation at Administrative Meeting.

 Any future amendments shall follow the same administrative procedures.
